We pray that as Friends we will always love and care for one another and for the Cathedral, and that we will always support the activities that take place within these magnificent buildings.

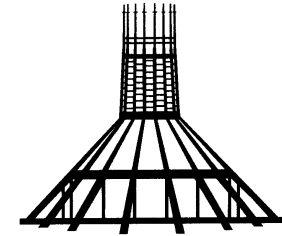
Bless the work of the Friends Association and sustain the Christian ethos and welcome that is at the heart of our Cathedral.
